Hi Mike,

As per our phone conversation earlier today, I wanted to follow up by e-mail about my pending FOIL request.

As you know, I'm the founder and president of a 501(c)(3) registered non-profit group called Reclaim The Records. We're a group of genealogists, historians, archivists, and journalists who acquire copies of old hard-to-access genealogical records using Freedom of Information laws, and then we scan them and put them all online for free public use, without any restrictions or copyrights or paywalls or anything like that. Basically, we want to help people find information about their families, even if they live outside of New York and can't go onsite to do the research in person.

And as you know, I made a FOIL request to your office late last fall asking if we could get copies (or preferably scans or digital photos) of the old Yonkers death records prior to December 31, 1915. The reason we want them up to 1915 is that starting in 1916 they were collected in the New York statewide death index through the New York State Department of Health. And we already got that statewide death index last year, through a separate Freedom of Information request we made to the New York State Department of Health. (It took seventeen months of work, but we eventually got them to scan it for us, for the first time ever!) But Yonkers records were not included in that record set for earlier years.

We've also gotten records in the past few years for the Buffalo death records 1852-1944 from the Buffalo City Clerk's Office, the New York City marriage license index 1908-1929 from the NYC Municipal Archives, the New York City marriage license index 1930-1995 from the New York City Clerk's Office, the New Jersey marriage index 1901-2016 from the New Jersey Department of Health and Human Services, and many other records sets like those. They all have gone online for free public use. Several of them have had (or are currently having) their images transcribed for the first time into free public text-searchable databases, which means that people can more easily find their relatives and ancestors in the records.

And we'd really like to do the same thing for the old Albany death records. It would be so great if they were online for free public use. And we're happy to pay for someone on your staff to digitally photograph or scan the old books for us, or we can hire a vendor to come onsite and do it, whatever you think is appropriate. Under the New York State Freedom of Information Law, I think the maximum you can charge is \$0.25 per scan or photo (or per Xerox copy, but we'd rather not have to deal with papers, digital copies would be so much better).

So I was wondering how many of these old books there are, and approximately how many pages there are, and what years they cover. You mentioned on the phone that you think maybe the death records start in the 1870's? And we only need up through the end of 1915.
