DAVID J. SPELLMAN, being duly sworn, deposes and says:

- 1. I am the Records Access Appeal Officer at the New York State Department of Health ("DOH") and respond to administrative appeals submitted to DOH by any person who believes he or she was denied access to governmental records pursuant to a Freedom of Information Law ("FOIL") request. The following is based upon my personal knowledge as well as my review of records maintained by DOH in the regular course of DOH's business.
- 2. I make this affidavit to oppose the Verified Petition of Reclaim the Records and Brooke Schreier Ganz ("the Requester") dated June 20, 2018 which seeks an Order: (a) directing respondent DOH to produce all records and documents responsive to Petitioners' October 17, 2017 FOIL request #17-10-253; (b) directing respondent to explain the manner in which records are kept that allegedly prevent a search for responsive documents; (c) directing respondent to produce information regarding its employees who conducted the search and their duties; (d) directing respondent to produce information about the subject matter of its records; (e) directing respondent to certify that a diligent search was conducted that failed to produce responsive

records and documents requested; (g) awarding petitioners costs and disbursements and legal fees and (h) any other and further relief as the Court may deem just and proper.

Applicable Law

- 3. The Freedom of Information Law is contained in Public Officers Law ("POL"), Article 6, §§ 84-90.
 - 4. POL § 89(4)(a) provides that

...any person denied access to a record may within thirty days appeal in writing such denial to...the person therefor designated...who shall within ten business days of the receipt of such appeal fully explain in writing to the person requesting the record the reasons for further denial, or provide access to the record sought...Failure by an agency to conform to the provisions of subdivision three of this section shall constitute a denial.

5. POL §89(4)(b) requires that a person denied access to a record in an appeal determination under the provisions of paragraph (a) of this subdivision may bring a proceeding for review of such denial pursuant to Article seventy-eight of the Civil Practice Law and Rules.

Petitioner's FOIL request

6. On October 17, 2017, the Requester submitted a FOIL request for

"all correspondence, emails, proposals, drafts, notes, agreements, contracts, meetings and calendar entries, phone logs, meeting minutes, budget items, receipts, vendorization forms or data, bids, evaluation materials, Freedom of Information Law (FOIL) records requests and their associated correspondence and any appeals, and any other documentation or communications between the New York State Department of Health and Ancestry.com, or such materials within the New York State Department of Health about Ancestry.com. Ancestry.com might also be listed as Ancestry, Ancestry LLC, Ancestry.com LLC, Ancestry.com holdings, Ancestry.com Holdings LLC, or similar terms.

I am requesting these materials for all dates between January 1, 2015 to October 17, 2017, inclusive."

A copy of the request is annexed hereto as Exhibit A.

7. On January 23, 2018, DOH issued a complete and final response to the request. This response constituted a partial grant of access to records and a partial denial as it provided the following:

- 1. Requester was provided with records responsive to the portion of the request concerning "Freedom of Information Law (FOIL) requests and their associated correspondence."
- 2. Requester was advised that the responsive materials provided in response to part 1 above contained redactions pursuant to POL § 87(2)(b) because disclosure would constitute an unwarranted invasion of personal privacy and § 87(2)(g) as inter-agency or intraagency materials.
- 3. Requester was advised that the New York State death index had been previously released to requester in response to a separate FOIL request.
- 4. Requester was advised that with respect to the portion of the request concerning appeals pertaining to Ancestry.com, no records responsive to the request had been located.
- 5. Finally, Requester was advised that the remainder of the request was denied pursuant to POL §89(3) as the request failed to reasonably describe the records sought with sufficient detail to enable DOH to locate them. The requester was asked to provide a list of specific employees whose communications the requester was seeking as well as the subject matter of the types of records sought.

A copy of the response letter is annexed hereto as Exhibit B.

- 8. On February 20, 2018, requester appealed DOH's January 23, 2018 response letter. A copy of the appeal is annexed hereto as **Exhibit C**.
- 9. On February 26, 2018, DOH responded to the February 20, 2018 appeal by upholding the response letter it in its entirety. A copy of the appeal determination letter is annexed hereto as **Exhibit D**. The determination advised the Requester that DOH correctly applied POL §89(3) with respect to the nineteen elements of the request as applied to all of the approximately 5,400 DOH employees.
- 10. The appeal determination noted that the email records for 5,400 DOH employees would need to be searched for all six permutations of Ancestry as well as the catch-all of "similar terms". Such a catch all is a never-ending, self-perpetuating haystack of similar possible terms.
- 11. Although the materials provided in response to the request included redactions pursuant to POL §87(2)(b) because disclosure would constitute an unwarranted invasion of

personal privacy and §87(2)(g) as inter-agency or intra-agency materials, the appeal did not contest such redactions and thus such redactions were not addressed in the appeal determination.

- 12. While Petitioner alleges that the appeal provided additional specificity as to the records sought, any additional details provided were still insufficient. The appeal stated that the subject matter of the request was business and contracts with DOH and Ancestry.com, yet the plain wording of the request does not support the conclusion that it was intended to be so narrowly construed. Additionally, the appeal states that emails sought are "likely" to belong to certain divisions of DOH and that "some of the relevant emails may be between" certain divisions. Again, this is insufficient to allow a comprehensive search to be completed. If RAO conducted a search that it knew may only uncover "some" responsive materials, this would not be an appropriate response to a FOIL request. There is nothing barring Petitioner from submitting a follow up FOIL request using more specific subject matter terms or limiting the universe of potential custodians to specific DOH divisions.
- 13. On February 26, 2018 I was advised that the appeal determination had been mailed to the Requester. Craig Rippon, a DOH administrative assistant whose duties include mailing appeal determinations, mailed said determination by placing it in a postage paid envelope using regular mail and depositing the envelope in a post office box or official depository of the United States Postal Service at the Empire State Plaza Post Office. This is the standard procedure used to mail all appeal determinations. An affidavit of mailing is annexed hereto as **Exhibit E.**
- 14. Additionally, on February 26, 2018, Craig Rippon forwarded a copy of the appeal determination to Robert Freeman, the Executive Director of the Committee on Open Government, pursuant to the provisions of POL § 89(4)(a). A copy of the email is annexed hereto as **Exhibit F**.

- 15. The DOH mailing envelopes are printed with DOH's full and accurate return address. Nevertheless, to date the appeal determination mailed to the Requester on February 26, 2018 has not been returned to DOH as undeliverable.
- 16. Based on the foregoing, DOH has fully complied with the requirements of the POL to appropriately and fully respond to Petitioner's appeal in a timely manner.

wherefore, it is respectfully requested that the Court dismiss the Petition in its entirety and deny Petitioner's request for attorney's fees and costs.

I am writing to appeal New York State Department of Health Records Access Officer Rosemarie Hewig's January 23, 2018 denial of of a portion of Ms. Brooke Ganz's FOIL request 17-10-253, originally submitted October 17, 2017. Ms. Ganz's original FOIL request sought:

Copies of all correspondence, e-mails, proposals, drafts, notes, agreements, contracts, meetings and calendar entries, phone logs, meeting minutes, budget items, receipts, vendorization forms or data, bids, evaluation materials, Freedom of Information Law (FOIL) records requests and their associated correspondence and any appeals, and any other documentation or communications between the New York State Department of Health and Ancestry.com, or such materials within the New York State Department of Health about Ancestry.com. Ancestry.com might also be listed as Ancestry, Ancestry.com LLC, Ancestry.com Holdings, Ancestry.com Holdings LLC, or similar terms.

Ms. Ganz's original FOIL request, the New York State Department of Health's Acknowledgement Letter, Extension Letter, and Response Letter Granting in Part and Denying in Part FOIL request 17-10-253, and the responsive materials received, are enclosed with this appeal.

Ms. Ganz was provided with documents responsive to the portion of her request seeking "Freedom of Information Law (FOIL) records requests and their associated correspondence,"

and was advised that there were no documents responsive to the portion of her request requesting "any appeals." However, the remaining portion of Ms. Ganz's request was denied; Ms. Hewig cited NYS Pub. Officer's L. § 89(3) for the proposition that insufficient detail was provided to enable the Department to locate the records. In particular, Ms. Hewig requested "a list of specific employees whose communications you are seeking, as well as the subject matter of the types of records you seek."

The requirement that Ms. Ganz supply an exhaustive list of names of employees who may have worked on the matter related to Ancestry.com is contrary to the spirit of the FOIL Law, which was enacted for the purpose of providing "the public with a means of access to governmental records in order to encourage public awareness and understanding of and participation in government and to discourage official secrecy." (Alderson v. New York State Coll. of Agric. & Life Scis. at Cornell Univ., 4 NY3d 225, 230 [2005]). The FOIL Law provides no public access at all if members of the public are required to provide the individual names of employees who worked on a particular matter in order to obtain information related to that matter, where the agency has provided no forum where members of the public can learn the names of various employees and the types of matters on which they work.

As the Committee on Open Government has noted in advisory opinions, "search mechanisms in electronic information systems often permit the retrieval of records based on a variety of possibilities, i.e., the use of dates, names, products, etc." See (Comm on Open Gov't FOIL-AO-17989 [2010]) [Note: FOIL Advisory Opinion]. Per the opinion of the Committee on Open Government, if an agency can locate records using the information provided in a FOIL request via an electronic search, it is required to provide the documents retrieved this way. Id. In her FOIL request, Ms. Ganz provided several search terms that could be used to search through the emails of Department of Health employees. Given the subject matter of the request—business and contracts between the Department of Health and Ancestry.com-emails sought are likely to belong to employees within the Department of Vital Records. In addition, some of the relevant emails may be between employees or agents of Ancestry.com and DOH employees who are member of the Division of Legal Affairs who work with the Department of Vital Records. The Department of Health's Records Access Office should be required, under the FOIL Law, to conduct a diligent search of the email accounts of employees of the DOH Office of Vital Records and the DOH Division of Legal Affairs who may have worked on a contract or project with Ancestry.com and its employees and/or agents.

Ms. Hewig's denial does not provide any specific reason for denying access to the other portions of Ms. Ganz's request seeking "proposals, drafts, notes, agreements, contracts, meetings and calendar entries, phone logs, meeting minutes, budget items, receipts, vendorization forms or data, bids, evaluation materials" related to Ancestry.com. As the Court of Appeals has noted, in denying a FOIL request because the documents requested were not "reasonably described," the agency must establish that "the descriptions were insufficient for purposes of locating and identifying the information sought." (Matter of Konigsberg v. Coughlin, 68 NY2d 245, 249 [1986]). Ms. Hewig's denial does not establish that the descriptions of the documents requested were insufficient; like in Konigsberg, Ms. Hewig provides no information about how these types

of records are indexed, so that Ms. Ganz would be able to locate them in a future request. Accordingly, the Department of Health Records Access Office should supply the records assuming they can be located using the search terms provided in Ms. Ganz's FOIL request #17-10-253, or else it should provide information about how these types of records are indexed to facilitate a future FOIL request.




